

Youth4clicks 2016 – Terms and Conditions

Structure

A workshop program for young photographers in India who will be taught nature and wildlife photography through practical on-field tutoring as well as theoretical aspects through presentations and demonstrations. The workshop is aimed at providing a platform to the deserving young photography enthusiasts who might have not have had similar learning opportunities owing to economic constraints.

Approximate per person cost of the workshop is to the tune of INR 1,00,000 each for 8 participants which will be borne by HCMF.

- a) The age of the participants attending the workshop will be less than 30 years on the date of commencement of the workshop.
 - b) The Workshop will be held at a National Park in India to be finalized by HCMF and Saevus Wildlife India
 - c) The workshop will be for 7 days and 6 nights.
 - d) Indian citizens resident in India involved in wildlife and nature photography being economically disadvantaged will be considered for the workshop through a transparent and just selection process.
 - e) The final 8 participants from the shortlist will be selected by the organisers
 - f) On being selected for the workshop, a non-refundable commitment fee of Rs.7500/- only will have to be paid by the participants.
- ** Following documents will be checked by Saevus & HCMF to verify the age and family income of the participants
Age: Birth Certificate/ Adhar Card/ PAN Card
Income: ITR V/ 3 months Bank Statement/ Salary slips
- g) Participants will have to make their own arrangement for travel to and fro to the workshop venue.
 - h) Participants are expected to bring their own equipment. Only in case of need and after evaluation, they will be provided camera and lenses and other equipment if necessary free of cost during the workshop.

i) Two renowned Nature and Wildlife photographers as mentors and also an on-field coordinator from Saevus & HCMF will be present for the entire duration of the workshop.

k) During the final review session, a conversation/presentation session will be included where participants will be expected to express their views on conservation and will be one of the judgment parameters in deciding the winner and runner-up
